Recovery Manager (RMAN) TSPITR enables quick recovery of one or more tablespaces in a database to an earlier time without affecting the rest of the tablespaces and objects in the database. Fully Automated (the default) In this mode, RMAN manages the entire TSPITR process including the auxiliary instance. You specify the tablespaces of the recovery set, an auxiliary destination, the target time, and you allow RMAN to manage all other aspects of TSPITR. The default mode is recommended unless you specifically need more control over the location of recovery set files after TSPITR, auxiliary set files during TSPITR, channel settings and parameters or some other aspect of your auxiliary instance. The following graphic shows a newly created CDB: * Creating a PDB Rather than constructing the data dictionary tables that define an empty PDB from scratch, and

then populating its Obj\$ and Dependency\$ tables, the empty PDB is created when the CDB is created. (Here, we use empty to mean containing no customer-created artifacts.) It is referred to as the seed PDB and has the name PDB\$Seed. Every CDB non-negotiably contains a seed PDB; it is non-negotiably always open in read-only mode. This has no conceptual significance; rather, it is just an optimization device. The create PDB operation is implemented as a special case of the clone PDB operation. When performing aBACKUP...VALIDATE, RMAN reads the files to be backed up in their entirety, as it would during a real backup.
